Information, Release and Agreement

TUITION

Student and Parent both understand and agree that Student's registration and this Release and Agreement must be received by the Youth Summer Design Workshop no later than the enrollment deadline accompanied by a \$100.00 non-refundable deposit.

Student and Parent further understand and agree that Student's participation entitles Student to only the standard arrangements and activities offered and/or scheduled, including, but not limited to, housing, meals, private motor coach transportation during the Workshop and educational materials. Generally, special arrangements and/or requirements desired or required for Student must be independently provided, and Student and Parent must bear the cost of any and all special arrangements and requirements. However, Youth Summer Design Workshop will comply with all federal, state and local laws in connection with this Release, including the Americans with Disabilities Act.

WAIT LIST

Both Student and Parent understand that all enrollments are processed strictly in order of receipt and that enrollments may exceed available space. Student and Parent further understand and agree that this is an application for participation, and Student's enrollment is contingent on final approval by the Interior Design Program, with whom sole discretion resides. Student and parent further understand that, if Student is not initially enrolled due to space availability, Student will be placed on a wait list and notified when space becomes available.

CANCELLATIONS AND REFUNDS

Both Student and Parent understand and agree that any cancellation and request for refund must be submitted in writing via email, FAX or US Postal Service, or overnight delivery, and must be signed by the Parent, Legal Guardian or Personal Representative who signed the Enrollment Application. Student and Parent further understand and agree that in order to offset costs incurred by the Youth Summer Design Workshop once it has received the Student's Enrollment Application, the following cancellation policy will apply:

Students who are dismissed from the Workshop for disciplinary reasons or leave the Workshop early for any reason are not eligible for refund.

POSTPONEMENT OR CANCELLATION OF THE WORKSHOP

Youth Summer Design Workshop reserves the right to modify, postpone or cancel a Workshop because of low enrollment, health, safety or other issues including, but not limited to, acts of God, acts or omissions of government authority, compliance with government regulations or any other cause or event beyond the control of Youth Summer Design Workshop.

In the event that Youth Summer Design Workshop postpones the workshop, tuition payments received prior to the postponement will be applied to the new Workshop dates. If Student elects to cancel his/her enrollment in a postponed Workshop, tuition will be refunded. Any cancellation and/or request for refund must be submitted in writing and signed by the Student according to the schedule stated in the *Student Cancellations and Refunds* section.

In the event that Youth Summer Design Workshop cancels a workshop, all tuition will be refunded. Youth Summer Design Workshop shall not be responsible for any expenses incurred by Student outside of those listed in the Tuition

section of this agreement, including, without limitation, all expenses for travel to the Workshop city and any other miscellaneous expenses incurred by Student.

EQUAL OPPORTUNITY

Youth Summer Design Workshop complies with all applicable federal and state nondiscrimination laws and does not engage in prohibited discrimination in employment or the provision of services. EMERGENCY MEDICAL AUTHORIZATION

I, the undersigned parent, guardian or Personal Representative, do hereby request, authorize and give permission to the Youth Summer Design Workshop or its duly authorized representative, to act on my behalf and in my stead, should my son/daughter complain of being ill, be injured or require emergency or other medical treatment, including hospitalization, during the Workshop. When seeking medical treatment, I understand that the workshop will use reasonable judgment under the circumstances and will defer to the expertise of any medical practitioner who provides services to my son/daughter. I expressly stipulate and agree that I will be solely responsible for all expenses incurred as a result of any accident, illness, injury incurred by my son/daughter, and will reimburse the workshop for such costs, and will release and hold harmless the Workshop and its directors, officers, management, employees, affiliates, successors and assigns, from all claims, demands, damages, expenses, whether known or unknown, resulting from, rising out of, or incident to the workshop’s pursuant to this authorization.
