4. Bidding Timeline

Bids due January 15, 2026 at 11:00 AM (note, this is updated from original Notice to Bidders). Bids must be received prior to that time in the specified location.

7. Project Scope Overview

Two new buildings are included within this project: the Baseball Locker Room Building and the Softball Locker Room Building. Both are bid under one package. Buildings are designed as "sister" structures with shared detailing.

8. Drawing Organization

Drawings are labeled either "B" or "S" for each building. Elevations and sections use a common base elevation with actual site elevations noted separately. Construction details apply to both buildings unless specifically noted.

9. Alternates

Alternate 1: Prefabricated covered walkway canopy connecting new buildings with existing dugouts at each field. Additional detail drawing to be issued in an upcoming addendum.

Alternate 2: Custom Cardinal logo carpet in locker rooms. Artwork provided by Ball State. Alternate 3: Locker front doors, priced separately for baseball and softball.

10. Locker Clarification

Lockers will be clarified as phenolic construction. Specification update to be included in an upcoming addendum.

11. Site Conditions and Logistics

Active athletic environment. Work coordination required with practice and game schedules. Construction activities restricted during home game times. Existing dugout restroom utilities to be reconfigured; restrooms temporarily offline during construction but expected to be reactivated as early as possible.

12. Parking

Construction parking anticipated near the softball side. Parking permits may be required and should be included in the bid.

13. Safety and Security

Temporary fencing and secure site conditions expected. Consideration should be given to public access during athletic events and tailgate activities.

14. Additional Ball State Context

Teams may practice in temperatures above approximately 40°F regardless of official schedules. Discussion noted regarding future practice field work adjacent to this project.

15. Site Visit

Site available immediately after the meeting. Contractors may walk the site independently or meet with staff. Questions following site visit should be submitted by email for written verification.

16. Next Steps

Second addendum forthcoming (date TBD) to cover RFI questions received to date. All questions are due by January 6, 2026. Second addendum expected to include canopy drawings, locker specifications, and related clarifications.
