AUTHORIZATION TO RELEASE STUDENT INFORMATION FOR RESEARCH PURPOSES

The Family Educational Rights and Privacy Act of 1974 (20 U.S.C. § 1232; 34 CFR Part 99) also known as FERPA, is a federal law that protects student educational records and access to the information contained within these records. FERPA protects your student records by prohibiting third party access to these records. While University officials can access FERPA information for legitimate education uses, such as grade assignments, billing, internal university assessments, etc., it prohibits the university from releasing FERPA protected information to any third party without your expressed written permission.

One such situation that falls outside of the legitimate educational uses provision is the use of FERPA protected information for research purposes. This includes all human subjects research that is governed by the "Common Rule" (45 CFR part 46) and is reviewed by the Institutional Review Board (IRB). This does not include situations such as course evaluations or quality improvement activities that would normally be conducted as part of any normal course process.

The BSU IRB and the Office of the Registrar has determined that while your faculty/course instructor or other university official may have access to FERPA protected information for legitimate university purposes, they do not have this kind of access for research purposes. As such, your expressed written authorization to release information, such as grades, billing information, etc., is required before they can access and/or use your FERPA protected information for research purposes.
