The Department of Homeland Security (DHS) and the Student Exchange Visitor Program (SEVP) requires each university to establish an estimated cost of attendance for the first academic year (9 months).

To determine the amount you must present for the purpose of the visa interview, subtract any financial support or scholarship you are getting from the "Total Estimated Cost of Attendance". This amount will also be listed on your I-20 document. You must present evidence for this amount in the form of a bank statement and Declaration of Financial Support (if the bank account presented is owned by someone else). You must also present evidence of any scholarship or other financial support you are receiving.

The **Undergraduate** "Total Cost of Attendance" was compiled based on double occupancy in <u>student housing with a standard 14 meals/week meal plan</u>. The cost for the mandatory student <u>health insurance</u>, <u>tuition and fees</u> are published on the BSU website. The cost for personal expenses, books, and supplies is an estimate and will vary for each student.

The **Graduate and Intensive English Institute (IEI) Only** "Total Cost of Attendance" was compiled based on estimated living expenses for in individual using the <u>MIT living wage calculator</u>. The cost for the mandatory student health <u>insurance</u>, <u>tuition and fees</u> are published on the BSU website. The cost for personal expenses, books, and supplies is an estimate and will vary for each student.

The Total Cost of Attendance listed is determined to be a reasonable estimate of the average cost of living for an individual for 9 months (a traditional academic year) in the greater Muncie, Indiana region.
