- B. Faculty and Professional Personnel Handbook updates will be made including the following:
 - Section 16.1.2.3.1 pertaining to Contract Faculty, the reference to the Vice President and General Council will now refer to the role of the Director of Affirmative Action once the update is completed.
 - The Military Leave language in the Faculty and Professional Personnel Handbook will be updated to be consistent with both the Bargaining Unit Handbook and the Staff Handbook.
 - Section 48.7.4.1: Faculty and professional personnel summoned to report for jury duty or to serve as a witness in court during regularly scheduled working hours will be provided time off with pay. Written notice or a copy of the subpoena must be submitted to department chairperson/supervisor and the appropriate vice presidential area prior to such duty. This policy does not apply to an employee who is a party to the legal action involved.

4. Committee Reports

- A. <u>Governance and Elections Committee</u> Karen Kessler Karen asked that anyone interested in serving as Chairperson, Vice Chairperson or Secretary for Senate, Councils, or Senate Agenda Committee to please make the current Chairpersons aware.
- B. <u>Faculty Council</u> Tarek Mahfouz- The Council met on March 22, 2018. They approved the February 2018 Minutes, and are working to form an Ad hoc Committee to begin addressing Dr. Jim Flower's item regarding adding a faculty member to the Board of Trustees. Senate Chair Koch met with President Mearns to open the discussion. The Council also approved that an Office Hours policy be added to the Faculty and Professional Personnel Handbook.

Several times a term, my office receives request for information or guidance on "required office hours" for faculty. More reports from the Undersecretary, UHRS representatives, and unit heads demonstrate that faculty and unit heads seek clearer direction.

Prior to 1990, the *Faculty and Professional Personnel Handbook* referenced office hours. Prior to 1990, faculty also completed a Schedule of Faculty form (time sheet) on which they listed their office hours, along with other duties. Many faculty, both those hired before 1990 and after, have come to believe that "2 hours per course" was required. There is no indication that the *FPPH* ever specified the number of office hours required, but the purpose of and need for office hours remains even in an electronic, accessible age. Faculty should provide specific times, places, and means for consultation with students and professional colleagues. Those times should be announced to students and colleagues alike.

Consequently, the following is recommended:

All academic departments, schools, and centers that employ faculty for any instructional load should develop its own policy regarding the manner in which faculty members are to be accessible beyond the actual class time. Policies are to be approved by the respective dean and kept on file in the dean's office. Additionally, policies are to be communicated to faculty at the time of hire or contract renewal.

Amending the University Constitution 2.0:

An Alternative Proposal for a Second Committee of Inclusive Constituent Composition
A proposal by Senator/ Professor Bruce Frankel: 4-16-2018

Method for Amendments, as Prescribed

This Constitution can be amended in the following manner: (1) presenting a written statement of the proposed amendment at a regular meeting of the University Senate and then at the next regular meeting of the University Senate securing a majority vote of those present and voting. If the proposed amendment receives such a majority vote, it will then be distributed to all faculty and professional personnel units; (2) securing approval of the proposed amendment by a two-thirds vote of all those present and voting at meetings held within the faculty and professional personnel units within sixty calendar days of notification for a unit meeting to be held, with vote results from each unit to be reported promptly by the unit Chairperson/Head to the Provost and Vice President for Academic Affairs; and (3) securing the approval of the University Board of Trustees for the proposed amendment.

Authorities

University Senate

University Senate shall advise the President, as follows:

- a. Strategic Plan of the University, its planning process conduct, its formulation, and its performance in effective implementation
- b. All matters outside the authorities of the three Councils, or that bridge two or more Council authorities

Faculty Council

Faculty Council shall advise the President as to all matters affecting faculty.

Student Council

Student Council shall advise the President as to all matters affecting students.

Professional Staff Council

Professional Staff Council shall advise the President as to all matters affecting professional staff.

Membership Senate

The University Senate shall be composed of 23 voting members, composed from the following constituencies:

- a. 10 members of the regular [tenue track and tenured] faculty [43.5%]; one chosen from each of the seven colleges [70%] and 3 at-large as chosen by Faculty Council [30%]
- b. 2 members of specialized [contract] faculty as chosen by Faculty Council [8.7%]
- c. 4 members of the student body as chosen by the Student Council, of which at least one shall be a graduate student [17.4%]
- d. 3 members of the professional staff as chosen by Professional Staff Council [13.0%]
- e. 2 alumni as chosen by the Alumni Association [8.7%]

f. 2 members of the external communities to be served by the University as chosen from individual nominations received by the University Senate [8.7%]

The University Senate shall be composed of the following ex officio, non-voting members, composed by virtue of their offices the President of the University, the Provost and Vice President for Academic Affairs, the chairpersons of the three councils, and one academic dean selected annually by all such deans to represent them.
