4. Questions Directed to President Mearns-

Provost Susana Rivera-Mills was present to answer questions. A short discussion ensued sharing the following concerns/topics but not limited to:

- 1. Administration has been sharing information on how to include the upcoming election and the importance of voting in class with students.
- 2. The Ball State University Police Department and Muncie Police Department are working to ensure safety throughout the process.
- 3. The University will provide support to students as needed.
- 4. The Provost, President Mearns and a Renae Conley of the Board of Trustees recently met with the Ad hoc Committee to discuss the proposal on adding a faculty member to the Board of Trustees. Renae will take the information back to the complete Board.
- 5. In preparation of post-Thanksgiving, an email will be shared with the Deans and departments giving guidance for the remainder of the fall term.
- 6. Beneficence Days-four additional days this holiday season, December 28th, 29th, 30th and 31st, will be given to all employees.

- 7. Planning for spring term continues including discussions with the Student Government Association and the integration of three (3) study days.
- 8. There is some discussion around requirements for students to provide COVID testing prior to returning to campus in the Spring. Challenges that students may face have been considered and communications will be shared with the students regarding testing a vailability.
- 9. The disproportionate effect of COVID on female faculty remains a point of discussion with a dministration. Faculty Council Chair Jon Truitt shared a helpful article with the Provost. The link is below.

make collective decisions or expressed opinions; and

Whereas: "In 2011, the Indiana General Assembly passed Senate Enrolled Act 32 and House

Enrolled Act 1242. The Governor signed both pieces of legislation, making vote centers

an option for any Indiana county;" 1 and



Whereas:	"A vote center is a polling place where any eligible voter in the county may go to vote;" and							
Whereas:	"The vote center model gives voters more flexibility on Election Day because they are not constrained to a specific polling location;" and							
Whereas:	"Vote centers are connected through secure internet connections, and as ballots are cast, an electronic poll book is instantaneously updated;" and							
Whereas:	A 2010 study done by the Ball State University's Bowen Center for Public Affairs found that Voter Centers save Counties who have implemented Vote Centers, money <sup>2</sup> ; and							
Whereas:	Forty-five (45) out of Indiana's Ninety-Two (92) counties have implemented Voter Centers since 2011.
