SCHOLARSHIP OF APPLICATION – THE DEVELOPMENT OF ELEMENTAL

In 2011, I worked alongside my colleague, Chad Menning, to develop a new kind of sexual assault protection program, called Elemental. The program, which is grounded in sociological and social scientific research (including original data collection), combines primary prevention programming on assault, consent, party culture, party safety and so forth with physical and verbal risk reduction training. During the seminar, students learn how to recognize sexual threats early, give and get consent, communicate with partners about sex, and use a variety of self-protection techniques that vary in intensity and level of violence.

Pretest, posttest, and longitudinal data from participants illustrate a strong, positive impact of taking part in Elemental. Students show strong, significant changes in their level of comfort saying no and standing up for themselves, their ability to set boundaries, their capacity to defend themselves in situations involving strangers, acquaintances, and intimate partners, and their understanding of sexual consent as well as alcohol and party dangers. These same measures are associated with a 66% reduction in the risk of assault for at least 6 months post-program. This is noteworthy because research on most existing programs consistently finds that they have only short-term effects on students' attitudes about assault and rarely impact rates of assault.
