Sponsored Projects Administration (SPA) is excited to celebrate with the Ball State University community its accomplishments in research, scholarly, educational, and creative endeavors throughout fiscal year (FY) 2018-19.

After a thorough peer review by the National Council of University Research Administrators (NCURA) and recognizing the needs of the campus community for additional research development support, SPA is now co-led with Jackie Davis serving as the Director for Sponsored Projects Development and Justin Miller continuing as the Director for Sponsored Projects Administration. This emphasis on development will provide a gateway to Ball State University's new strategic plan, Destination 2040: Our Flight Path. We will continue to refine policies and procedures and have created our SPA mission statement and guiding beliefs, so that we may achieve the highest level of service possible throughout each sponsored project's life cycle:

In addition to sharing the accomplishments of many faculty, professionals, staff, and students, this magazine includes the FY 2018-19 records pertaining to SPA. Figures include grants, contracts, and funding awarded to the Ball State University Foundation that resulted in sponsored programs. We are also eager to share sponsored project expenditure data for the first time in this report.

Executive Summary: SPA currently manages Ball State's sponsored project portfolio of approximately \$45 million. For FY 2018-19, more than \$21.4 million in external funding was awarded to Ball State, a 50% increase over the previous year. In addition, 421 proposals were submitted during the fiscal year, and 211 funded awards were recorded. Research expenditures topped \$3.8 million, and expenditures from all sponsored projects exceeded \$23 million.

We extend our appreciation to all who carried out the challenging work of preparing and administering sponsored projects, both internal and external - awarded or not - and recognize the efforts and commitment represented by all who are actively engaged in the pursuit of extramural funding: faculty, professionals, staff, students, and administrators alike.

On behalf of the first-rate and hard-working SPA staff, we offer our warm regards and best wishes for continued success.




#### EXTERNAL FUNDING OVERVIEW



Funded and Submitted by External Grants FY15-19," reflect totals for all sources of external funding for Ball State projects, including the aforementioned Foundation support and centers.


#### External Dollars Received FY15-19

#### **Staff Updates**

In reviewing campus needs, administrative support, in response to a peer review by our professional organization, the National Council of University Research Administrators (NCURA), and in preparation for the University's strategic plan, SPA developed a new organization structure. This new structure, co-led by Jackie Davis, Director for Sponsored Projects Development and Justin Miller, Director for Sponsored Projects Administration, allows for increased staff in our Compliance and Contracts team. Under the direction of Sheila Shafer, Associate Director for Compliance Operations, SPA added three new Contract Compliance Coordinators: Donald Davidson, Brittnie Sell, and Rebecca Tyler. With the promotion of Rebecca Tyler, Katie Wilkinson joined the team as the Secretary for Compliance Operations. We wished all the best to Ted Kolodka, Contract Compliance Analyst, who is continuing his career at Notre Dame University.

In February 2019, SPA celebrated the retirement of Lee Anne Shore, Grant Manager and was happy to welcome Malissa Garrison as a new Grant Manager.

## **Program Offerings and Support Programs**

#### Research Week, 2018

This weeklong spotlight on research and sponsored projects includes lectures each day from faculty honorees. For 2018, we celebrated the accomplishments of: Lenny Kaminsky, Director of the Fisher Institute for Health and Wellbeing; Allison Rober, Assistant Professor of Environmental Biology; and Ron Morris, Professor of History.

#### **SPA Fellows Program**

The 2018-19 SPA Fellows cohort consisted of 8 new faculty selected by the Provost, Vice Provost for Research and college deans. This year-long intensive educational program is designed to develop knowledge and grantwriting skills in support of externally funded research, scholarship, creative projects, or other fundable endeavors. The Fellows program is led by Jackie Davis, Director for Sponsored Projects Development. Since its inception in 2012, 96 faculty have completed the program.

#### Indirect Cost Recovery Distribution

Per University policy, of the \$870,133 in indirect costs recovered by the University, currently: 5 percent goes to principal investigator(s), 10 percent to departments/units, and 5 percent to colleges. During the past year, the following amounts were transferred: \$34,156 to Pls, \$106,912 to departments/centers, and \$43,511 to colleges—for a total distribution of \$184,579.

#### **SUBMIT Incentive Program**

The SUBMIT program encourages external proposal development and submission. Proposals that are submitted at a minimum of \$15,000 and follow the University Proposal Submission Policy, will receive funds placed into a Research Incentive Account (RIA) of the Principal Investigator (PI)/Co-Principal Investigator(s) to support scholarship and professional development. During the past year, 169 proposals received SUBMIT funds with a total amount of distribution being \$73,450.

#### ASPIRE INTERNAL GRANT PROGRAMS

Ball State University's Internal Grants program was created in 1965 to provide funding to faculty and students and to support and develop projects in the areas of research and creative endeavors. ASPiRE Internal grants are intended to supplement and strengthen the support for research and creative endeavors that comes both from departmental and college resources along with other University programs.

Ball State Internal Grants program offerings consisted of the following competitions this fiscal year: Junior Faculty Research, Junior Faculty Creative Arts, ADVANCE, CREATE, New Faculty Start-Up, Reprint/Publication Support, Travel Support for External Funding for faculty, International Travel Support, and Hollis as well as Graduate Creative Arts, Graduate Research, Undergraduate

Creative Arts, Undergraduate Research, and Travel Support for Professional Meetings for students.

#### 2018-19 Program Participation

The ASPiRE Internal Grants program processed 299 student proposals and awarded \$117,985 to support 260 projects. The increase of funding to support this larger number of funded projects was graciously provided by the Graduate School for Academic Year 2018-19. Faculty programming funding remained static and resulted in 116 faculty proposals and awarded \$266,430 to support 94 projects.

#### INTELLECTUAL PROPERTY

Intellectual property development remains an integral component to the research enterprise at the University. SPA is responsible for receiving and evaluating intellectual property disclosures regarding copyrightable or potentially patentable works. SPA works closely with the Ball State Innovation Corporation (BSIC) to direct commercialization and licensing activities related to Ball State's works of intellectual property.

During FY19, nine (9) intellectual property disclosures were made, while FY19 royalties totaled \$57,140. An itemized list of the works generating royalty income is below. ## **Food Summit**

The Local Food Summit brings together stakeholders in Delaware County and East Central Indiana to join forces in building a more equitable, resilient, and sustainable local food system.

The summit is collaboratively organized by the Muncie Food Hub Partnership, Purdue Extension, the Delaware County Food Council, and Muncie residents. The overarching goal is to bring together stakeholder groups in the areas of local food production, distribution, consumption, education, and

governance to work toward creating food solutions for our community.

#### Related objectives include:

- sharing current initiatives among food access organizations working to create a more resilient, equitable, and sustainable food system
- identifying barriers to food access and generating communitybased solutions
- soliciting input from stakeholder groups to inform development of the Muncie Food Hub
- identifying leadership and input to further develop Delaware County's local food council that is working to shape local food policy and actions

2019 marked the fourth annual Local Food Summit. The daylong conference featured Kelsey Timmerman as the keynote speaker, followed by a locally sourced lunch, then concurrent sessions led by local leaders. The sessions were geared toward information sharing and solution development. The later afternoon featured a panel of area farmers and chefs discussing the barriers, opportunities, and strategies toward sourcing and utilizing local products in east central Indiana. This was followed by a networking session highlighting Guardian Brewing Company and vendors from local food-related organizations.
