Candidates in the Elementary Education Transition to Teaching Program complete a 10-week student teaching, while the Secondary Transition to Teaching Program completes the more traditional 16-week student teaching experience. The 10-week duration still meets the minimum length per Indiana Administrative Code and the Elementary Education Department voted to increase the length of weeks to a total of 16 by the 2021-22 academic year. Supervision is done in a combination of "in-person" visits and virtual visits by using WebEx or GoReact Conferences, due to the distance from campus of many of the students in the program. Candidates are spread out all over Indiana and are also allowed to be on an Indiana Emergency Permit or Indiana Transition to Teaching Permit. Prior to obtaining the Transition to Teaching permit candidates have to be approved by a sponsoring school district, with the Indiana Department of Education issuing the permit. When applicable, candidates who complete post-bac initial licenses that are not in the Transition to Teaching program complete the same requirements as traditional program completers (i.e., 16-week student teaching, same courses, etc.).

Ball State University has a Transition-to-Teaching (T2T) program at both the Elementary and Secondary levels. The Elementary T2T program requires 24 semester hours, six (6) semester hours of which must be in reading. The Secondary T2T program requires 18 semester hours. Candidates in the program must have a bachelor's degree in a related field and must pass the state licensure exams. The T2T program's primary focus is on pedagogy. The basic requirements for T2T are established in Indiana State Law. Individuals who complete the Elementary T2T program receive an Indiana Elementary license. Individuals who complete the Secondary T2T program receive an Indiana license in grades 5-12 in their content area (i.e., Life Science, Mathematics, English, etc.). Individuals who complete these program have the option of taking additional courses and earning a master's degree, but this is not a requirement to obtain the Indiana license.

The accreditation and assessment coordinator worked with all programs in 2020 to align courses required by all candidates in their program to InTASC Standards related to technology. Use of technology is embedded in methods and field experience courses throughout the preparation program. During the student teaching experience, edTPA is required. The program provides significant technology support to the candidates to facilitate this learning. The program is working on establishing a set of modules that meet both InTASC and ISTE Standards. ## Teacher Training

#### a. Teach students with disabilities effectively

Students in Transition to Teaching (Elementary) learn about the needs of students with disabilities in a variety of ways. In their courses they learn about the process of teaching and learning, how to differentiate their lessons for a variety of students, and how to use resources to locate assistance with students who have disabilities. They also complete edTPA portfolios during student teaching which focus on students with IEPs and other educational needs.

#### b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Students in Transition to Teaching (Elementary) work in diverse classrooms, with many children who have IEPs. They are encouraged to participate in all IEP conferences, assist with differentiated planning and assessment, and communicate with families (when appropriate).

#### c. Effectively teach students who are limited English proficient.

Students in Transition to Teaching (Elementary) learn a variety of methods and strategies to assist students with Limited English Proficiencies - especially in their two reading courses. They also complete an edTPA portfolio in student teaching, in which they focus on differentiation for this population of students.

#### a. Teach students with disabilities effectively

Evidence-based practices in the graduate and undergraduate methods courses include Direct Instruction, explicit instruction and remedial strategies in literacy instruction, supporting student learning using graphic organizers, learning strategies and organizational skills. Opportunities for application occurs in the advanced practicum, taken concurrently with the undergraduate methods course. Writing lesson plans and unit plans with specific learning needs in mind is a major focus at the undergraduate level.

#### b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

A 5-week IEP unit in SPCE 376, Methods in Mild Interventions K-6, focuses on all components of IEPs as well as the IEP process/case conference committee and eligibility determination. The emphasis is on writing Present Level of Academic Achievement and Functional Performance, annual

goals, and accommodations. Using a case study, students write an IEP in groups of four. In the graduate mild interventions methods course, SPCE 688, a book on writing IEPs is one of two required textbooks. Based on a case study, candidates write components of an IEP and respond to in-depth focus questions targeting IEP procedures and components.

**c. Effectively teach students who are limited English proficient.**

Culturally Responsive Teaching and Sheltered Instruction (IRIS Module) are included in the course material. Candidates in SPCE 376 have to complete an assignment based on the IRIS Module, Teaching English Language Learners: Effective Instructional Practices, as well as a differentiated instruction lesson that includes EL learners. At the graduate level, SPCE 686 (Introduction to Mild Disabilities) includes assigned readings and reflections on student differences, including cultural and language differences. Candidates in the methods course, SPCE 688, develop and teach a differentiated instruction lesson. After teaching the lesson, they have to reflect on the process, including the impact of student differences (cultural and EL students where appropriate) on learning. EL learners are not specifically targeted since many of the teachers who are taking this course do not have EL students in their classrooms.

Ball State University has a Transition-to-Teaching (T2T) program at both the Elementary and Secondary levels. The Elementary T2T program requires 24 semester hours, six (6) semester hours of which must be in reading. The Secondary T2T program requires 18 semester hours. Candidates in the program must have a bachelor's degree in a related field and must pass the state licensure exams. The T2T program's primary focus is on pedagogy. The basic requirements for T2T are established in Indiana State Law. Individuals who complete the Elementary T2T program receive an Indiana Elementary license. Individuals who complete the Secondary T2T program receive an Indiana license in grades 5-12 in their content area (i.e., Life Science, Mathematics, English, etc.). Individuals who complete these programs have the option of taking additional courses and earning a master's degree, but this is not a requirement to obtain the Indiana license. Even though many of the candidates opt to get the master's in T2T, since it is not required, we have been advised to not count them in the section "Teachers Prepared by Academic Major."
