### **Vice Provost for Academic Affairs**

Responsibilities

In this position, I am responsible for providing support and guidance for all processes and procedures connected to academic affairs at the University, except for the Graduate School and Sponsored Programs and Grants. My office also manages academic integrity and grade appeals, student complaints, new faculty orientation and development, department chair professional development, and the curriculum review process. I am the advisor and ex officio member of the University Promotion and Tenure committee, and responsible for all appeals that come to that committee. I am also the Academic Affairs representative to the Indiana Commission for Higher Education. The Director of Research and Academic Effectiveness, who is responsible for all student evaluations of faculty teaching, reports to me. Other direct reports include the Assistant Provost for International Programs, which includes the Intensive English Institute, and the Director for the Center for Peace and Conflict Studies.

## Major Contributions

During the short period in which I have served, I accomplished the following:

- Reorganization of Academic Affairs: Phase 1 in Fall of 2018, Phase 2 beginning in Jan. 2019. Developed a new and more clearly organized flow chart for this area, which significantly increased my portfolio.
- Strategic planning for Academic Affairs for my direct reporting units for 2018-2040 was completed by April 1.
- Assumed responsibility for monthly Indiana Commission of Higher Education meetings and took over as PI for the Transfer IN continuing grant (Spring 2019).
- Took over as Accreditation Liaison Officer for the Higher Learning Commission. Attended annual HLC conference in March.
- Unit Review Sub-Head with Adam Beach, SEP 2.0 Steering Committee
- Chaired a successful search for a new Dean for the College of Communications, Information and Media
- Created, developed, and implemented the inaugural year (2017-28) of a monthly Professional Development program for Department Chairs. Took over New Administrators Orientation.
- MAC-Academic Leadership Development Program. April 11-12, Toledo, OH.
- Created, approved, and implemented Tested Experience Policies for all departments, in compliance with HLC regulations
- Conducted Crucial Conversations training sessions with emerging leaders on campus
- I lost my entire office staff and had to rehire from the bottom up. Although it took some time, I am proud of the strong, efficient, collaborative group that I have assembled.
- Hired to replace the sudden departure of the Executive Director for International Programs. In the face of declining international student enrollments, I collapsed leadership of the Rinker Center for International Programs and the Intensive English Institute, thus saving an administrative position and producing cost savings as well as a more cohesive leadership model.
- Most significantly, during a time of sudden distress at the University, I stepped into the role of Acting Associate Provost with no training. There has been a steep learning curve, but I managed to keep all operations running smoothly and in many cases I have made improvements to the systems that were previously in place.

### Associate Dean, College of Sciences and Humanities, July 2008- June 2016

### Responsibilities

The College of Sciences and Humanities is the largest college on campus, with 20 (during my term) departments encompassing the natural sciences, the social sciences, and the humanities. My primary responsibilities as Associate Dean included: chairing the college curriculum committee; managing course enrollments, load reports, and fill rates; overseeing student affairs, including student complaints, late withdrawals, grade appeals, and the Dean's advisory council;

and events planning, including Commencement, the Dean's Honors list reception, Preview days for potential students, admitted student receptions, and the Circle of Excellence dinner.

## Major Contributions

- My first year as Associate Dean, the University implemented a new core curriculum; 75% of these courses were in our college, which meant they all had to be revised and resubmitted for approval through our college curriculum committee. I accomplished this efficiently and effectively.
- When I first took over as Associate Dean, all of our systems were still using paper. I immediately moved our College Curriculum Committee to Blackboard, allowing for everyone to see exactly where the proposals were in the system and for the paperwork to be processed more quickly. With the procedures streamlined, meetings became a place for intellectual engagement to advance thinking about curricula and pedagogy.
- By closely monitoring section enrollments, I dealt pro-actively with changes in student demand and core curriculum requirements, as well as external factors such as the state implementation of a 120 hour limit to all programs.
- Tightened our late withdrawal and change of grade procedures to make them not only more efficient, but also more fair. I eliminated about 50 hours per semester of work with the new system that I designed.
- Was the primary support person in our college for Assessment, and when the University went through HLC accreditation in 2013 our Dean was co-chair of the University Accreditation committee, leaving all our College accreditation tasks to me. I focused on our college assessment practices as a professional measure of our public accountability and as a workable method, designed by faculty, to promote high expectations for student learning and progressive, responsive and effective pedagogies.
- Understanding that our humanities and fine arts students were competitively
  disadvantaged at the annual Undergraduate research symposium, which featured only
  poster sessions. I worked with the research office to permit the submission of research
  papers and, in the first year, reviewed all the papers and arranged them into panels
  chaired by faculty that allowed students to display more fully the rich nuances of their
  research.
- In order to promote faculty scholarship, I worked with Sponsored programs to create a series of workshops, "Grants Essentials," designed to develop the untapped potential of faculty in our college to connect successfully with external grant opportunities, thus helping the college achieve a critical strategic plan performance metric.
- Successfully chaired three University level searches for academic leadership positions.
- Worked with all our departments to successfully migrate to Digital Measures as a record keeping tool.

## **Initiator of new programs/courses**

**ENG 299X: Visual Media and the Secondary Education Classroom**. This special intensive workshop was designed to introduce students in English Education to the complex connections between literature and film, and to discuss the potential incorporations of film into the secondary classroom. Students were able to build on the basic information offered in ENG 300 in order to make the connection to pedagogy and teaching methods more apparent.

**ENG 300 (now 425): Film and Literature**. In spring of 1999, I proposed a completely new course description in order to reflect a radically revised focus for the course. As of Fall semester 2000, this course now has a lab time for screening films, better technological support in an improved environment, and the course content is more aligned with current trends in the field.

**ENG 400: (Special Topics) Narrative Theory and the Living History Museum**. This course was created as part of the Provost's Immersive Learning Initiative and was team-taught as a block with Dr. Mary Theresa Seig's ENG 323 Discourse Analysis Course, in partnership with the Living History Museum at Conner Prairie.

**ENG 402: (Cultural Studies) Film and American Culture**. This course examined the impact on American culture of cinema, from its beginnings in the late 19<sup>th</sup> century through the current new wave of digital technology, using four critical approaches to American film: history, economy, genre, and ideology. This course was later taught on the graduate level as ENG 656.

Honors Colloquium (ENG 390), Reality Bytes: Theories of Realism in Fiction, Art, and Film. This colloquium explored various theories of representation, realism, and truth, beginning in the late 19<sup>th</sup> century, through several different genres: fiction, drama, auto/biography, film, popular culture, and emerging technologies.

Film Theory and Criticism (654). Initially offered as a summer course for graduate students designed to enhance their pedagogical training, this seminar was expanded and first offered in a regular semester in fall 2002. The course serves as an introduction to technical terms and concepts, as well as to the basics of cinema history, (inter)national cinema movements, and methodology, and allows students to explore new critical approaches found within current film and media studies.

Gender Studies: Theory and/of the Body (655). This course was developed to allow our graduate students with some background in feminist, gender, and queer theory to explore more fully current trends in the field.

## **Teaching Fellowship**

Virginia Ball Center for Creative Inquiry, "The Expectation of Excellent: Girls, Sports, and Community." Awarded fall semester of 2007. In this seminar, I explored with the students the cultural significance of Title IX by first tracing its historical connections to Indiana through former Senator Birch Bayh, and then focusing on two specific examples of its impact: the extraordinary accomplishments of the University of Tennessee Lady Vols basketball head coach, Pat Head Summitt, and the equally amazing local success of Steve Shondell, coach for the national championship Burris High School Lady Owls volleyball team. The culminating produce was a documentary film and photo exhibit which offered a portrait of the expectation of athletic excellence here in the Heartland. Students explored history, employed ethnographic methods of inquiry and discovery, learned and practiced photography, cinematography, and editing in HD resolution, increased their visual literacy, examined the vicissitudes of practical civics, and investigated how statistics are gathered and interpreted. They further documented their experiences with a public blog, as well as through a second, behind-the-scenes film. Budget: \$15,000. See here:
